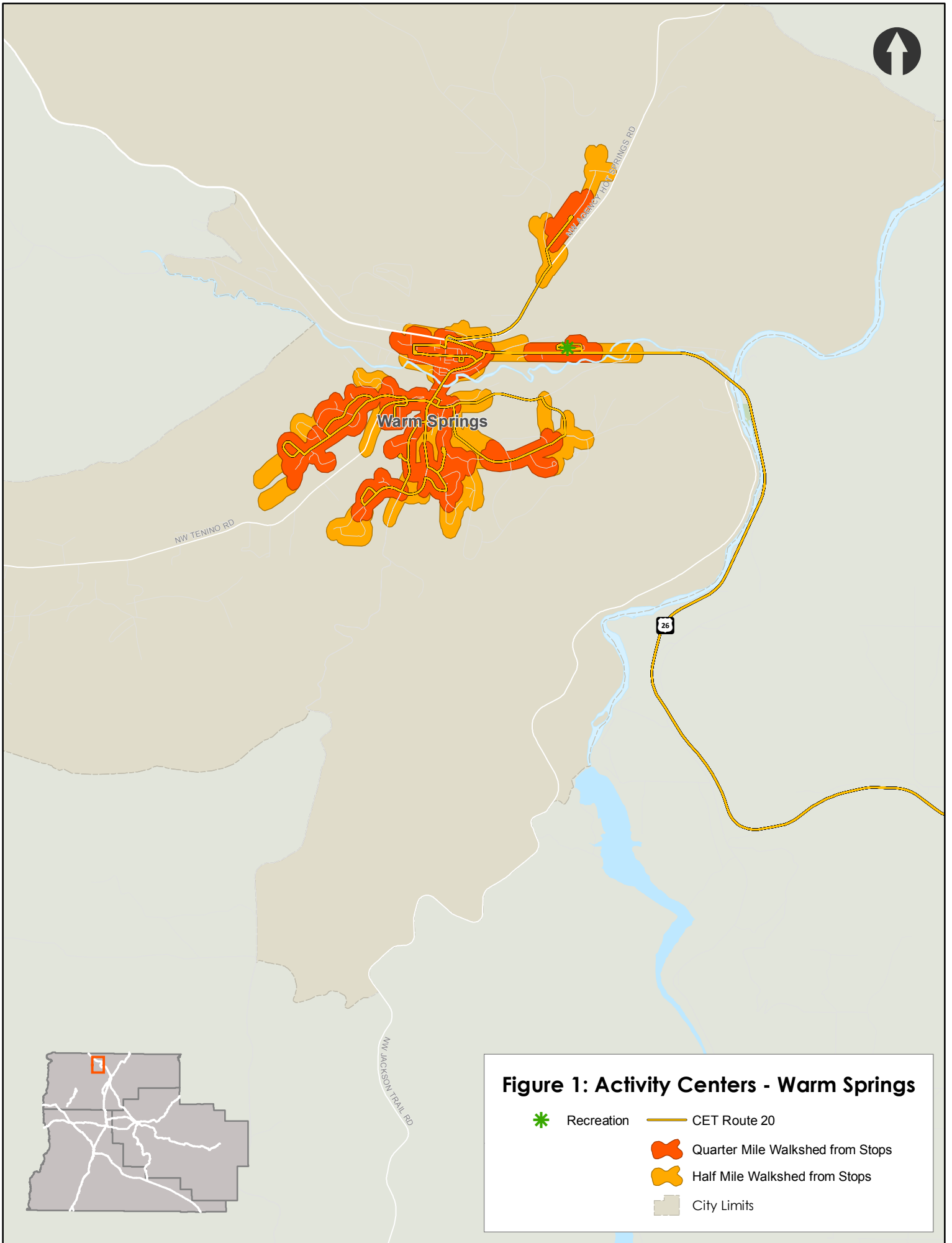


Figure 1: Activity Centers - Warm Springs

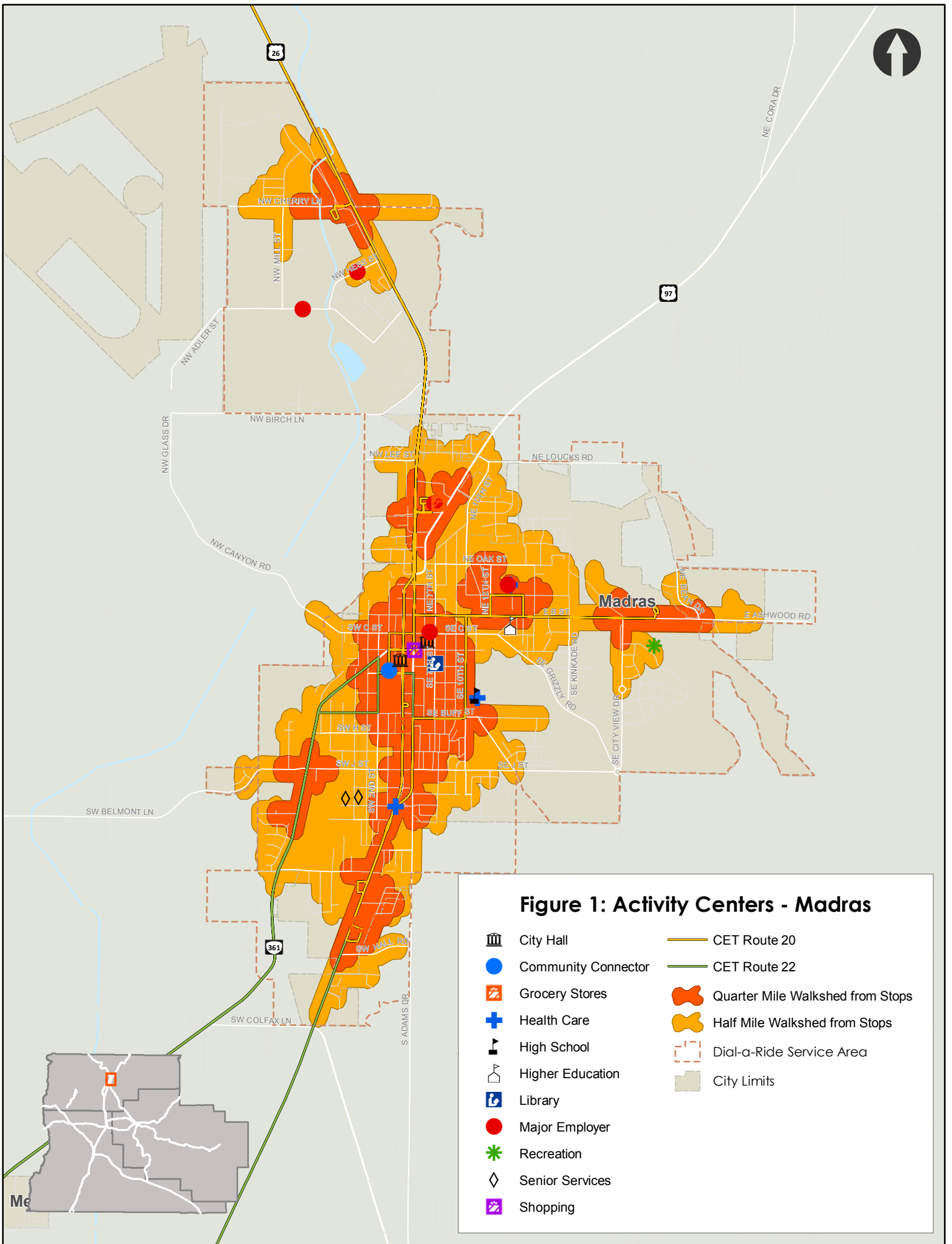

















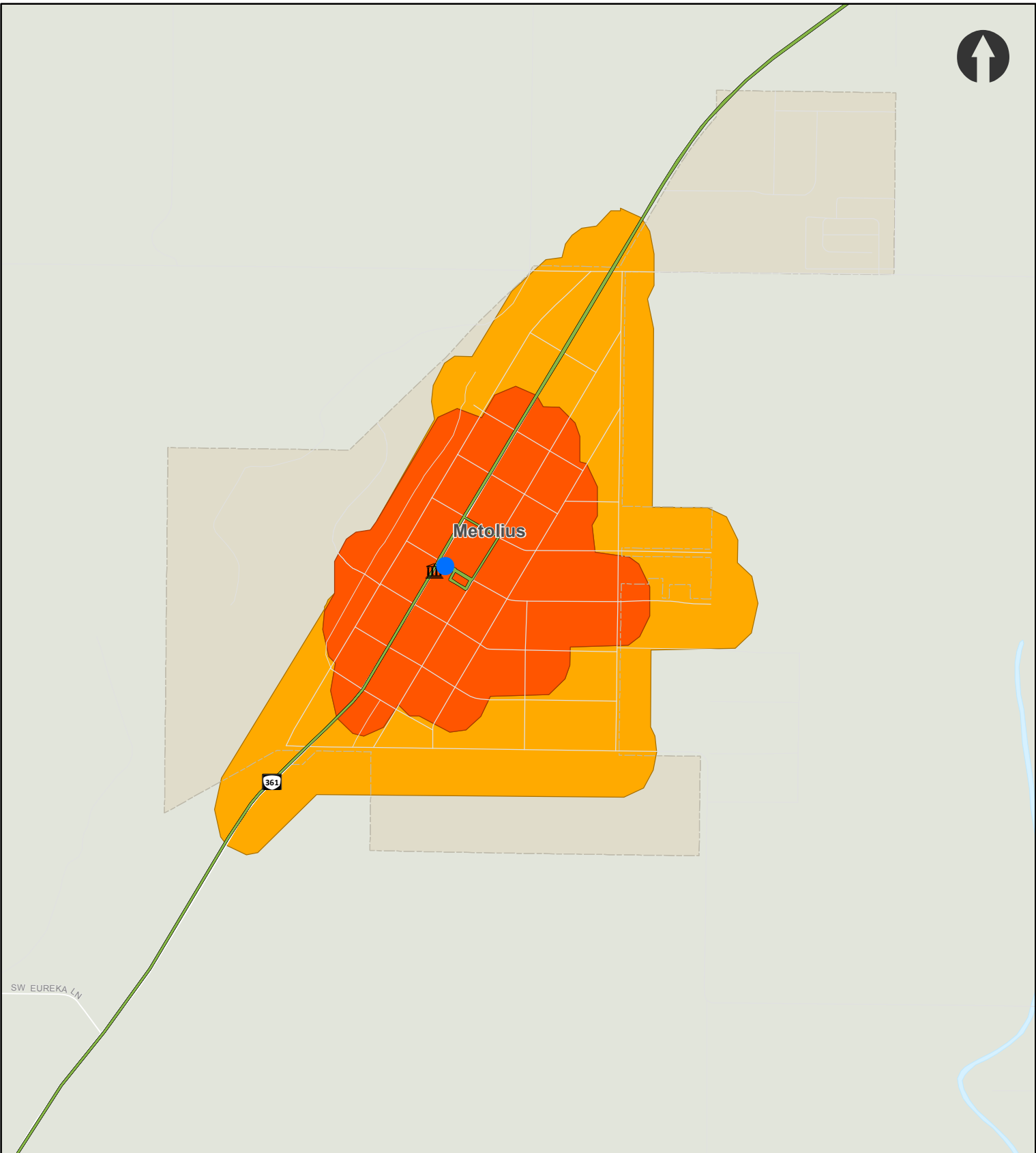


Figure 1: Activity Centers - Madras

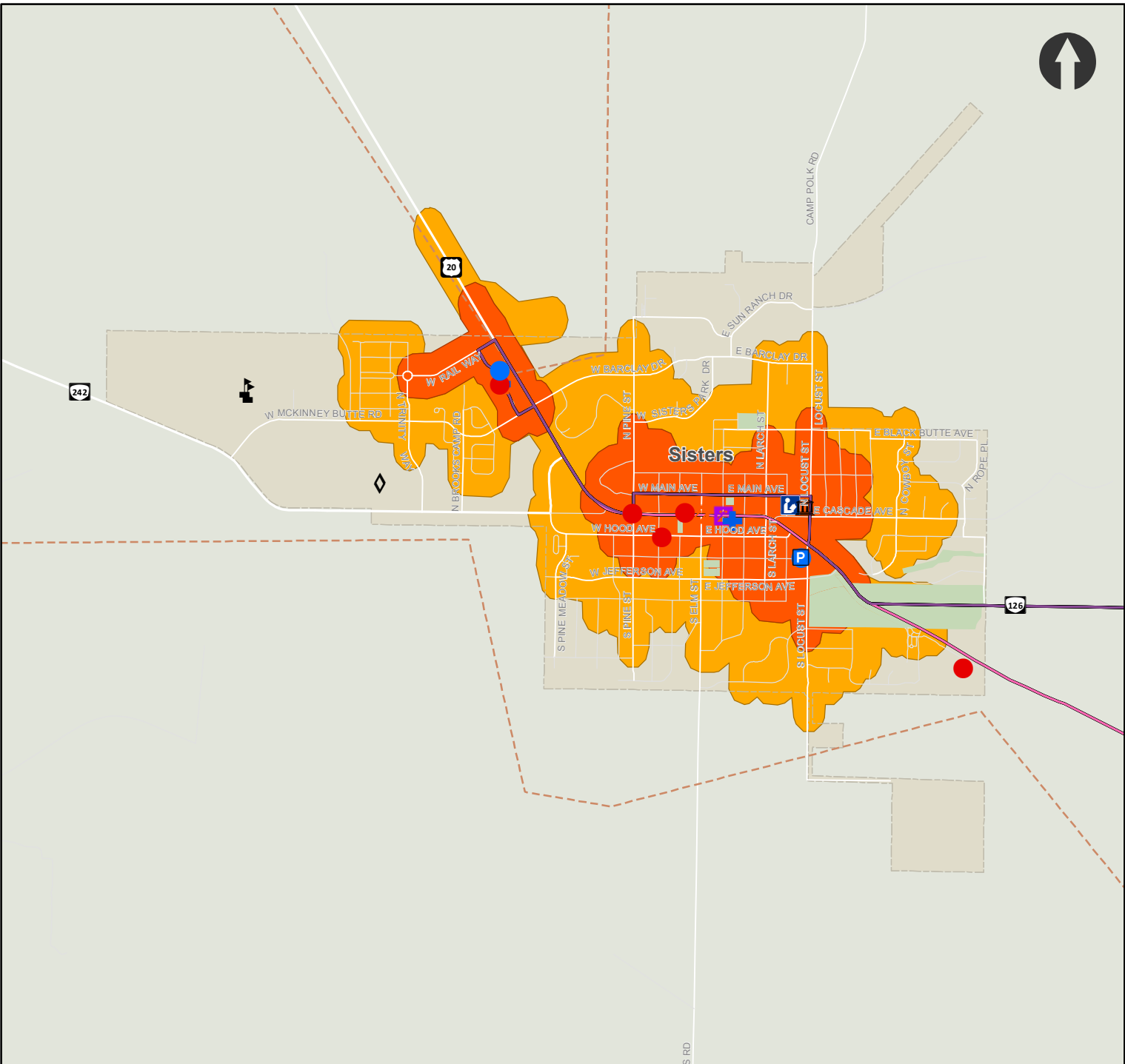
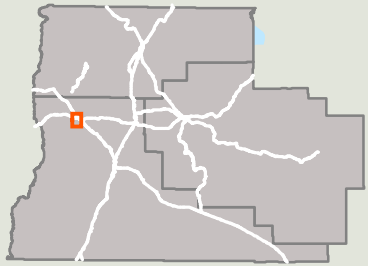


Figure 1: Activity Centers - Sisters

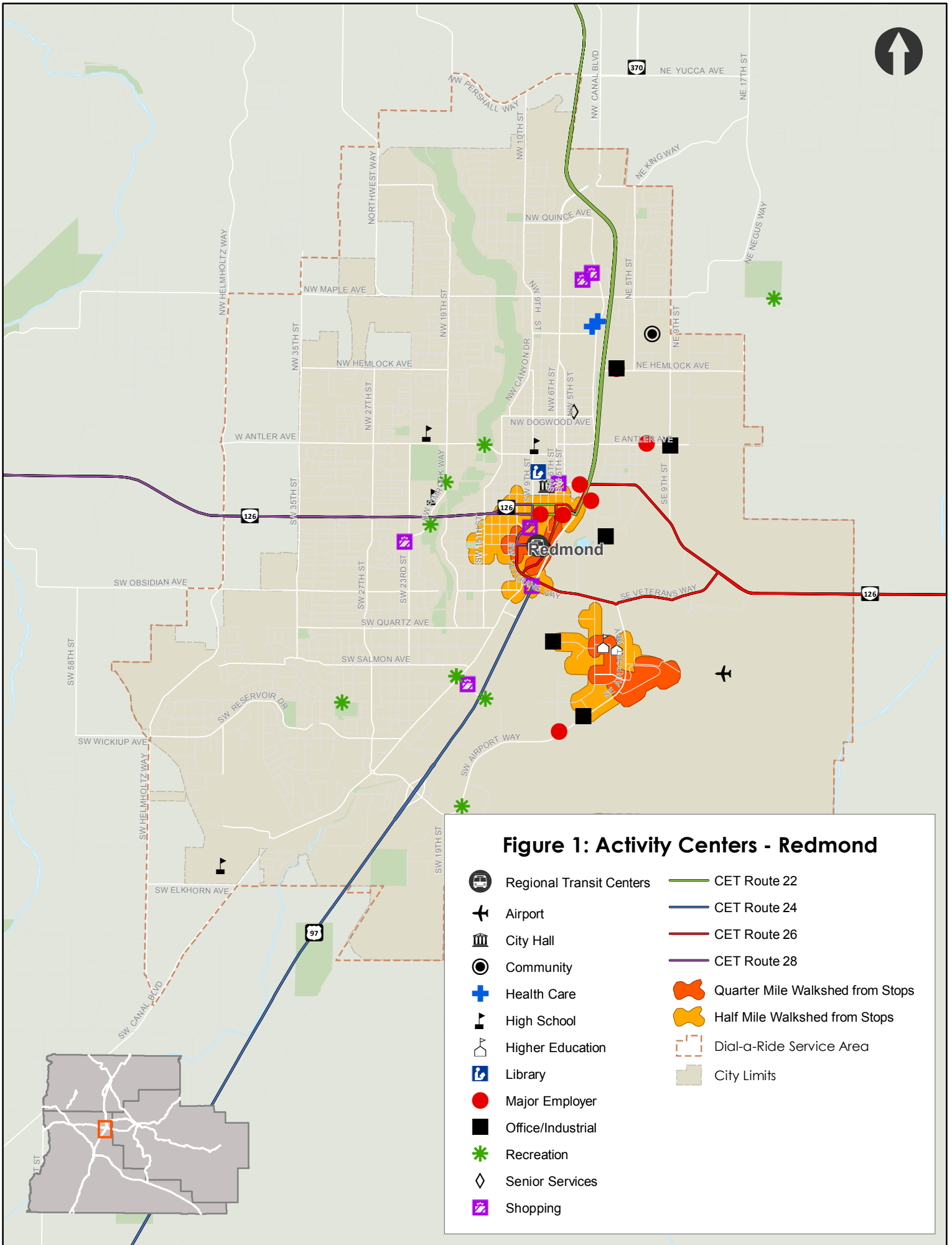





















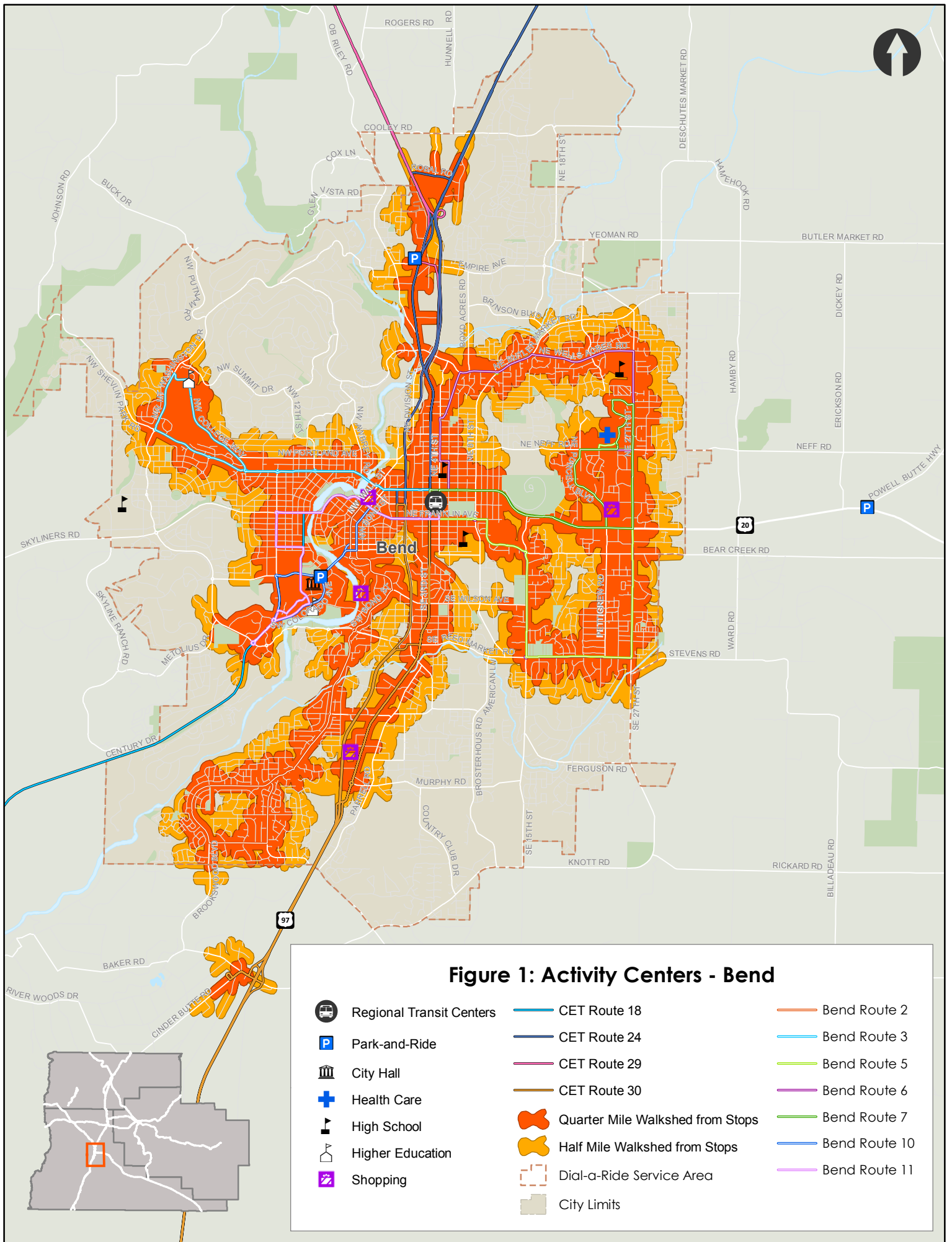
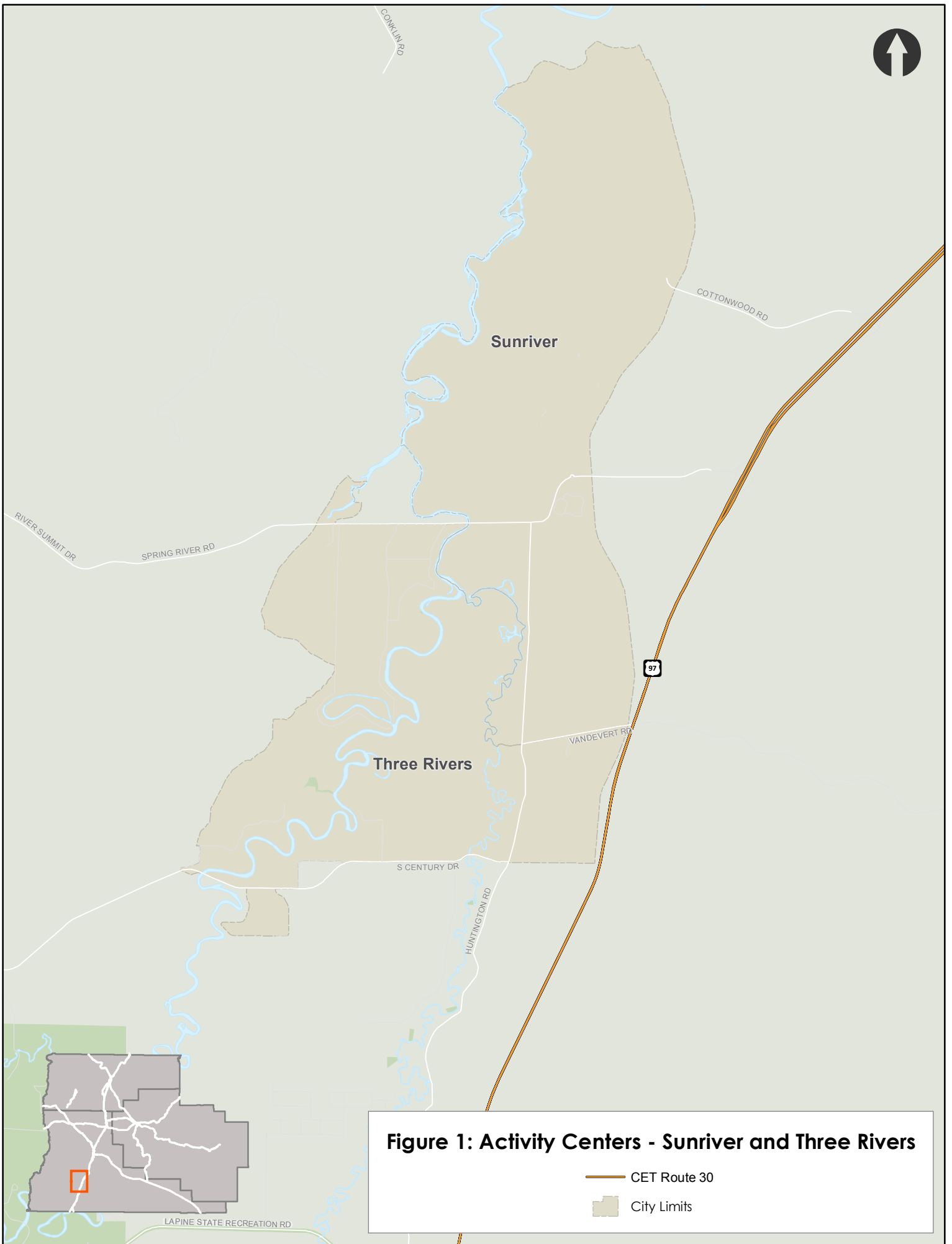
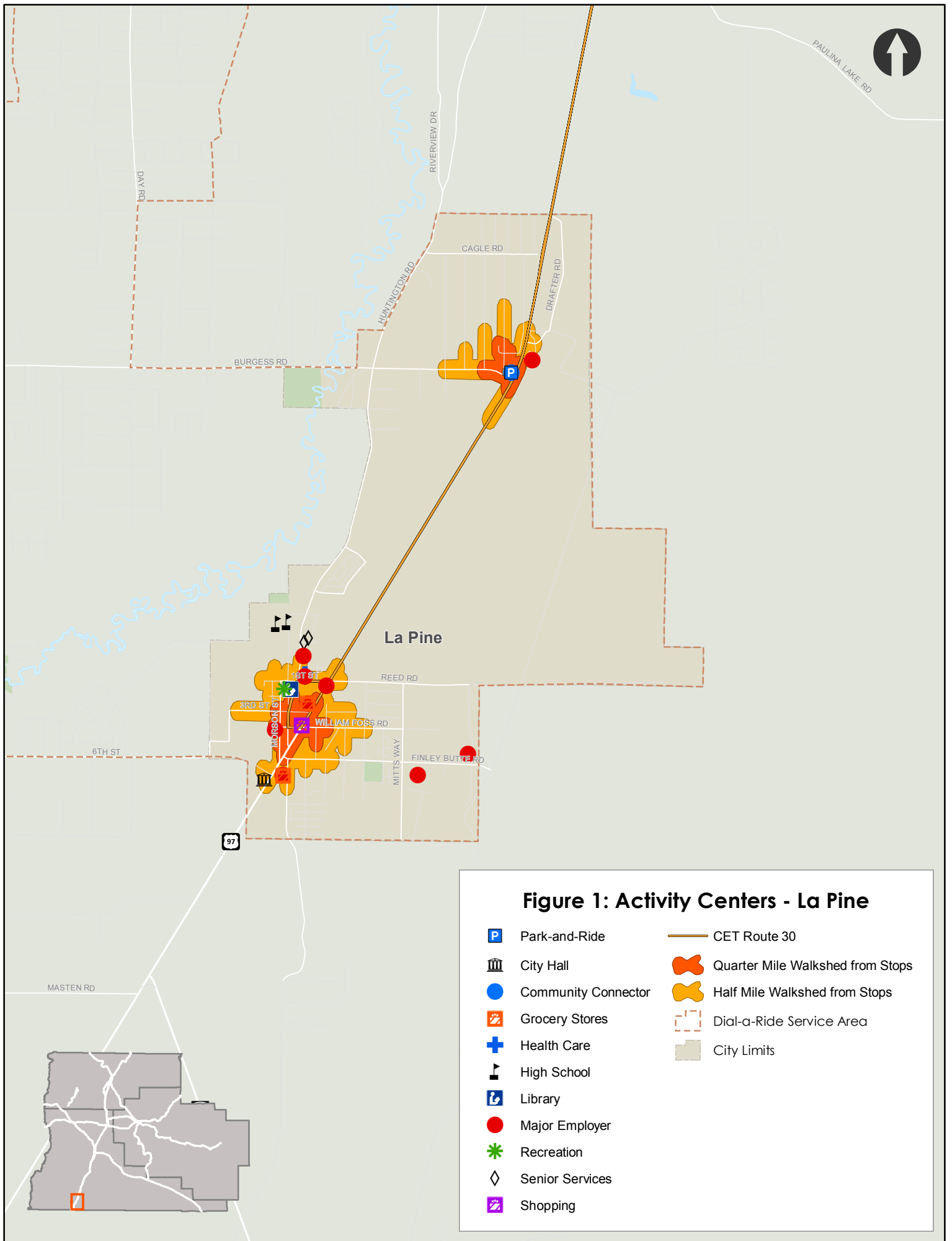


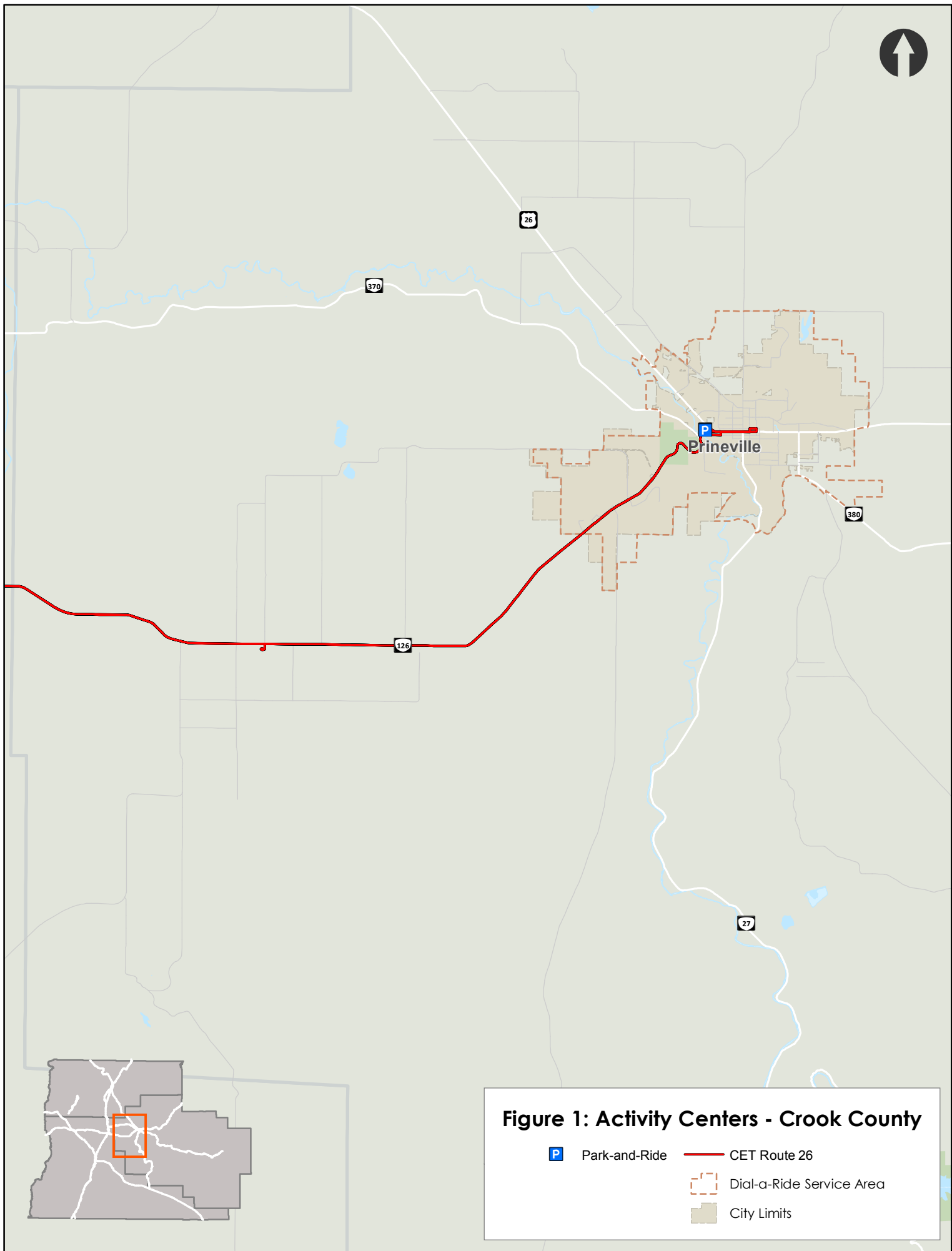
Figure 1: Activity Centers - Redmond

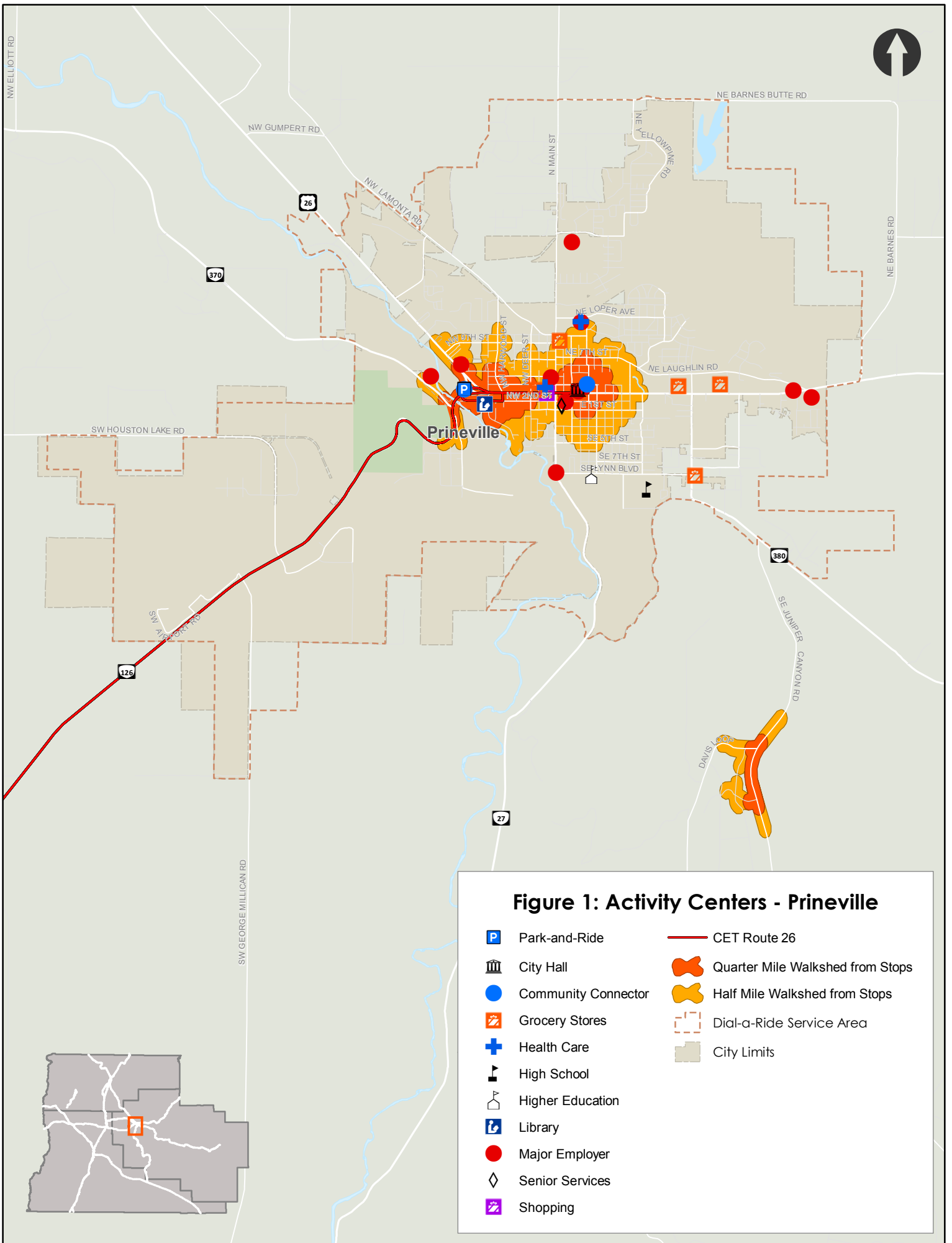


Figure 1: Activity Centers - Prineville
